

Position: Assistant or Associate Professor of Business Administration

The position also requires advising undergraduate students, providing service to the college and community, assisting with program activities, and continuing professional growth and development. A doctorate in business or related field from a regionally accredited institution is preferred and teaching experience is desired.

## **Current Program Need:**

Faculty to teach undergraduate and graduate level courses in Business:

Candidates with eighteen graduate hours in the discipline are strongly encouraged to apply.

- Must have excellent organizational, communication, teaching and decision-making skills.

- Experience with Open Educational Resources (OERs).
